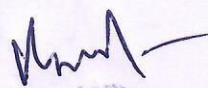

- vi. **PERFORMANCE SECURITY DEPOSIT:** Upon acceptance of tender, Performance Security is to be furnished by a specified date [generally 21 (twenty-one) days after notification of the award] and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the contractor, including Defect Liability Period (DLP). The total amount of Performance Security Deposit shall be 3% of the contract value. Tenderer must attach DD in favor of REVAMPED SFURTI LOK KALYAN SANSTHAN payable at BARMER. as Performance Security. It would be refunded to the contractor without interest, after he duly performs and completes all obligations under the contract but not later than 90 days of completion of the Defect Liability Period (DLP), after satisfactory installation and commissioning of Machinery at the CFC. The performance security will be forfeited and credited to the procuring entity's account in the event of a breach of contract by the contractor.
- vii. Samiti reserves the right of forfeiture of Security Deposit in addition to other claims and penalties in the event of the contractor's failure to fulfill any of the contractual obligations or in the event of termination of contract, as per terms and conditions of contract.
- viii. Bidder shall mandatorily enclose specification sheets, operation & safety manual, quality of material along with financial bid
- ix. Technical specification of the machine covered in the scope of the works should be mentioned.
- x. **Quality Assurance:** All hardware, motor, gear box and pump to be supplied/ used in machinery must bear ISI/ BIS / ISO or equaling registration mark
